<p>An Analysis of the contributing factors to Paediatric Patient Safety Incidents in Emergency Departments</p> <p>Reidy and O'Dea address the issues around paediatric safety issues. Factors consistently encountered are ED overcrowding, deviations from protocols, and communication problems.</p>	926
<p>Clinical utility of ABR testing under general anaesthesia in Autistic children</p> <p>Nae et al. report that among 59 children with autism who had a hearing test under the general anaesthesia there were only 2 cases with an abnormal result. In view of the low yield, the authors suggest that a hearing assessment that does not require a general anaesthetic is needed.</p>	927

Comorbid Chronic Diseases and Ventilatory Support in COVID-19 Hospitalisations Philip et al. describe the interaction of Covid-19 with existing co-morbidities. This group of patients had higher rates of non-invasive ventilation and an increased risk of mortality.	928
Thrombolytic therapy in ST-elevation myocardial infarction Murray et al. conducted a retrospective case control study of 21 thrombolysis and 42 PPCI control patients who had a confirmed STEMI.	929
Early Medical Abortion – Education and Training Experiences McAuliffe et al. surveyed medical students and GPs on their opinion about medical abortion training. 92% of students, 75% of trainers, and 54% of trainees felt it should be mandatory.	930
Health Needs Assessment and Chronic Pain Kiernan et al. report that a health needs assessment of patients with chronic pain placed a high priority on the alleviation of disturbed sleep, and pain on movement.	931
